- You should be a diplomate of the European College of Veterinary Internal Medicine (ECVIM) or the American College of Veterinary Internal Medicine (ACVIM). Individuals with extensive clinical experience who are ECVIM or ACVIM board-eligible will also be considered. In addition, a current veterinary license (RCVS) in good standing is required.
- Fluency in English is required for this position, in fluency in at least one other European language is strongly preferred. Additional language skills are an advantage in this international company.
- A collaborative, service-oriented approach to work is essential in our team, as is ability to work independently.
- Computer literacy and a reliable, high-speed internet connection (minimum speeds of 30 Mb/s download and 5 Mb/s upload) are required.
