## **The Position**

The tenure-track position includes the option of negotiating a qualification agreement (QV in accordance with Section 27 of the Collective Bargaining Agreement for University Staff). The initial contract will be as a postdoctoral assistant with QV option. When the QV is signed, the position will be reclassified as an assistant professorship. When the provisions of the qualification agreement are met, the job holder will be promoted to tenured associate professor.

- Information about experience in organization, management, leadership
- Concept for research, teaching and (non-)clinical services
- Contribution to the academic profile of the Department or Vetmeduni

The Vetmeduni aims to increase the proportion of women among scientific and general university staff, especially in management positions, and therefore explicitly invites qualified women to apply.
